NOTICE OF DISPOSITION – DOCKET 2020-3

This notice reflects proposed amendments considered by the Commodity Classification Standards Board (CCSB) at the public meeting on October 6, 2020, and the action of the CCSB on each proposal.

Dispositions resulting in amendments to the National Motor Freight Classification® (NMFC®) will be published in a supplement to the NMFC, unless reconsideration is granted in accordance with the CCSB's rules. The supplement is scheduled to be issued on November 19, 2020, with an effective date of December 19, 2020.

The CCSB may, in its discretion and for good cause shown, reconsider any docketed proposal on which disposition has been made. Requests for reconsideration must be made by mail, email or fax by a party of record to the proposal and must be received in my office no later than 5:00 pm Eastern Time, October 26, 2020.
